THE GOA APPROPRIATION BILL, 1994

(Bill No. 8 of 1994)

A

BILL

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State of Goa for the services and purposes of the financial year 1994-95.

BE it enacted by the Legislative Assembly of Goa in the Forty-fifth Year of the Republic of India as follows:—

1. *Short title.*—This Act may be called the Goa Appropriation Act, 1994.

2. *Issue of Rs. 7,83,28,41,000 out of the Consolidated Fund of the State of Goa for the financial year 1994-95.*—From and out of the Consolidated Fund of the State of Goa there may be paid and applied sums not exceeding those specified in column 5 of the Schedule, amounting in the aggregate to the sum of seven hundred eighty three crores twenty eight lakhs and forty one thousand rupees towards defraying the several charges which will arise for payment during the financial year 1994-95 in respect of the services and purposes specified in column 2 of the Schedule.

3. *Appropriation.*—The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Goa by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said financial year.
