Postponed Calling Attention tabled by Shri Michael Lobo, MLA.

"Fear and anxiety in the minds of the people, specially educated unemployed youth of Goa, that foreign nationals who are in Goa on Tourist Visa carrying different types of business such as restaurants, private shacks, tourist guides, tour operators etc., thereby depriving our local Goan youth who are unemployed and who wants to start their own business. Action the Government intends to take for permanent closure of foreigners, illegally carrying business in Goa."

Reply by Hon. Minister for Home:

Sir,

The Police Department has conducted enquiries through SDPOs of North District against foreign nationals in Goa on tourist visas, carrying different types of business, such as restaurants, private shacks, tourists guides, tour operators, etc. In cases of violation of Visa, illegal activities, the Police department has taken action against foreign nationals under Goa Daman & Diu Tourist Trade Registration Act, 1982 for doing illegal guiding job and in some cases for conducting business while on Tourist Visa. The details of the foreigners against whom action is taken for doing illegal guiding job during the year 2013 and 2014 are indicated at Annexure A.

The Superintendent of Police(L&V), Panaji has directed all SDPOs & I/Cs of Police Stations in North District to maintain strict vigil and to take appropriate legal action against the foreigners, if found indulging in illegal business activities.

A meeting was held under the chairmanship of Hon'ble Chief Minister on 08/02/2014 to discuss various issues related to tourist taxi operators in Goa including foreigners doing business of taxi operation. In the meeting, it was decided to start a Joint Squad comprising of officials of RTO, Tourism Department, FRRO, Traffic Police and local Police for tourist related problems in general and checking of illegalities in the tourist taxi business in Calangute, Anjuna and Pernem area in particular.

A special squad comprising of officials of RTO, FRRO, Traffic and local Police was constituted and is functioning in two shifts since 12/02/2014 in Calangute Police Station jurisdiction.PCR Van Robot-15 is allotted for Special squad.

Further, the Department of Tourism is responsible for the implementation of Goa Registration of Tourist Trade Act, 1982. The Department has been compounding the offences booked under the relevant sections of the Goa Registration of Tourist Trade Act, 1982, whenever such instances are noticed or brought to the notice of the Prescribed Authority from time to time, by imposing penalty for malpractice or default in Registration. The Department has further constituted two independent Flying Squads headed by Assistant Director of Tourism and two surveillance and monitoring teams under Assistant Tourist Officers for the two districts of the State in order to have a check on such activities. The Department of Tourism has compounded 14 such cases during 2013-14 by imposing penalty on defaulters. Detailed list of such cases wherein penalty is imposed on foreigners is enclosed as Annexure-B.

In view of the continuous efforts of this administration, the people of Goa need not worry about the matter.

The Government is committed to protect the interest of the Goan youth.
