"FEAR AND ANXIETY IN THE MINDS OF PEOPLE OF PORIEM CONSTITUTENCY SATTARI TALUKA REGARDING THE DRAFT NOTIFICAITON OF THE GAZETTE OF INDIA –EXTRAORDINARY PART II- Sec 3 (ii)) of Wednesday, July 6,2022 declaring 56 villages of Sattari as "Eco Sensitive Zones" which is not acceptable, as villages cannot be declared as Eco Sensitive Zones without plan of action in place. Decision and request the Ministry of Environment and Climate Change to drop the 56 villages of Sattari'

Sir,

The Ministry of Environment Forest and Climate Change first notified the first Draft notification of Ecological Sensitive Areas for Western Ghats for the 99 villages identified by the Kasturirangan Committee by S.O.No 733 (E) dated 10/03/2014. The following 99 villages have been published in the Draft Notification as ESA:-

The Hon'ble Chief Minister, Govt. Of Goa represented vide letters dated 16/04/2014, 08/07/2014 & 20/04/2015 respectively to Minister for Environment & Forest, Government of India to withdraw the notification and carry out physical survey before issuing Notification.

Thereafter the Ministry has re-issued the said Draft Notification vide S.O.No 667(E) dated 27/02/2017. The Hon'ble Chief Minister, Govt. Of Goa represented vide letter dated 18/04/2017 to Minister for Environment & Forest, Government of India requesting for inclusion of only 19 villages in lieu of the 99 villages included in the draft Notification.

S.O.No 5135(E) dated 03/10/2018. The Secretary (Environment) represented vide letter dated 17/6/2019 to MoEF&CC, Govt. Of India to only consider 59 villages which are already within the existing Protection Regime in the Notification and drop the rest. In the said letter it was also proposed to include 10 other villages which are contigious to the 59 villages included in the Draft Notification to be included in the Final Notification.

The MoefCC than once again issued Draft Notification vide S.O.No 632 (E) dated 25/06/2020. The Hon'ble Chief Minister and Hon'ble Minister for Environment represented vide letters dated 10/01/2020, 9/07/2020, 13/7/2020 & 28/12/2021 respectively to Minister for Environment & Forest, Government of India putting forth the views of the State Government that only some villages meet the criteria prescribed for the inclusion of villages as part of ESA of Western Ghat and also to include only part villages and not full village as proposed considering the existing habitation and plantation of the local population residing in the villages.

Now the MoefCC has issued fresh Draft Notification vide S.O.No 3072(E) dated 06/07/2022 once again including the same 99 villages inspite of the various representations made by us.

The Hon'ble Chief Ministers of the State during their tenure as well as me as Environment Minister have been continuously representing to the Ministry of Environment Forest and Climate Change in order to put forth the view of the State Government.

The Kasturirangan Report basically focuses on two aspects so as to include those villages which can find a mention in the final notification on Ecological Sensitive Areas of Western Ghats

- a. Taluka/Blocks should be 600 meters above the Mean Sea Level (MSL) and 20 percent of the Area of Taluka / Block should be 600 meters above MSL.
- b. The village should be contiguous to the Western Ghats in the neighbouring States i.e Maharashtra and Karnataka.

There are errors in the Notification with regard to the name of the villages, their spellings etc and the same have been highlighted in the letters issued by the Hon Chief Minister as well as letters issued by me. The State Government has minutely verified the applicability of the criteria and it is observed that only 26 villages which are of such nature that have an elevation of 600 meters above MSL.

There are 4 talukas, whose parts are falling in the Ecological Sensitive Areas of Western Ghats. In all 4 cases only minuscule percentage of total area is 600 meters of MSL i.e Canacona, (0.20 %), Dharbandora (2.54 %), Sanguem (4.93 %) and Sattari (4.88%). Hence none of the 4 talukas qualify to be included in the ESA of the Western Ghats. The analysis has been done by using the contour maps prepared by the Geological Survey of India and it is found that only 26 villages are found to meet the criteria for Western Ghats.

• 11 villages are in Sattari Taluka.

The State Government has also examined the height of the remaining villages and out of these only 4 villages meets the criteria of 600 meters above MSL but are not contiguous to the Western Ghats of neighboring villages. The other villages are having height of below 580 meters of MSL.

I would like to emphasise that out of the total geographical area of 3702 sq. kms. of Goa, the State is hardly left with just 342 sq. kms area (only 9.25%), which can be made use for growth and development (Table below).

In addition to above, the total forest & tree cover of the State of Goa is more than 66%. This is because people of Goa have culturally and historically been protecting the environment and Forest.

The Hon'ble Chief Minister therefore represented to the Central Government that having examined the existing protection regimes and ecological sensitive areas in the State, and in order to prevent overlapping protection regimes and maintaining uniform boundaries of such areas to include the **59** villages meeting the required criteria as well as contiguity which are included in the Draft Notification for Western Ghats Ecologically Sensitive Areas as this are already part of the Protection Regime.

All the 69 villages proposed for inclusion are already a part of the protection regime and hence the State Government has proposed their inclusion.

The State Government requested the Ministry to exclude the remaining 40 villages from the final Notification for Western Ghats Ecological Sensitive Area in the State of Goa which are non contiguous as well as not meeting the criteria for Western Ghats.

The State Government has also informed the Ministry that while notifying the Wildlife sanctuaries as well as Eco Sensitive Zones in the State of Goa natural boundaries such as rivers, streams, nallahs etc or roads etc have been taken into consideration and therefore part of the villages are within the protection regimes. The State of Goa has been pro-active in protecting ecology and environment in these areas and therefore considering the size of the State as well as high percentage of area under protection regime only part of the villages as mentioned

in the annexure may be considered while issuing the Final Notification . This will also ensure that boundaries of such protected areas are uniform.
